## **GENERAL INSTRUCTIONS FOR APPLICANTS**

- 1.** Application should be submitted along with photo copies of Matriculation/10<sup>th</sup> pass, marks sheet, Age proof, Aadhar card and other related documents to Deputy Director, Senior Citizens Division, National Institute of Social Defence (NISD), Ministry of Social Justice & Empowerment, Government of India, Plot No. G-2, Sector-10, Dwarka New Delhi - 110075. (For further information meet us : 📞 011-20893989)
- 2.** All claims made in the application must be supported with documentary proof in original at the time of interview.
- 3.** Incomplete application or the application received after the last date will not be accepted.
- 4.** Qualified candidates will be called for Interview/Counseling.
- 5.** Candidates called for interview/counseling will have to make their own arrangements. No TA/DA will be paid by NISD.
- 6.** Employees of State or Central Government or of any Public Sector Undertaking of State or Central government should send their applications through their employers. However, the advance copy of the application (complete in all respects) can be submitted. In case the application is not received through the employer before apply, a NO OBJECTION CERTIFICATE from the employer should be produced at the time of interview/counseling failing which the candidate will not be allowed to appear for interview/counseling.
- 7.** List of all the qualified candidates and list of candidates called for interview/counseling will be notified on the Institute's Notice Board. No separate individual intimation will be given. Non receipt of notice by any individual candidate will not vitiate the selection process having regard to publication of result as also schedule on the notice board and the website. The decision of the Director in all matter regarding selection will be final and no representation in any form will be entertained.
- 8.** The decision of the Director of the Institute shall be final in all matters of selection of candidates for admission to the course and no appeal shall be entertained on this subject.
- 9.** No individual intimation will be sent to candidates who are not selected and no correspondence on this subject will be entertained.
- 10.** This course is conducted on a full time basis. The candidates are not permitted to undertake any other part time or correspondence courses.
- 11.** To appear in the final examination & viva-voce evaluation, a student should have at least 80% attendance in the class and at least 80% attendance in Block placement separately. The attendance for the fieldwork will be calculated as per the number of days attended.
- 12.** The rules and regulations in this may change in accordance with the decision of the Institute from time-to-time.
- 13.** All candidates admitted to the Institute shall maintain good conduct, attend their classes regularly and abide by the regulations of the Institute.

## **Warning**

In case any candidate is found to have supplied false information or a false certificate or is found to have withheld or concealed some information, he/she shall be debarred from continuing the course and shall face such appropriate action initiated against him/her by the Director of the NISD.

Use of cell phones, radios etc which is likely of disturb the class is strictly prohibited inside the classroom.
